During Teerlink's 18 years at Harley-Davidson, he served as Chief Financial Officer, President, Chief Executive Officer, and Chairman of the Board. He currently serves on the boards of directors of Johnson Controls and Snap-on Incorporated. He is also a frequent speaker to business organizations internationally,

Like Teerlink, Kyle used innovative strategies to help his company achieve tremendous growth. While serving for 24 years in executive leadership at SMS, he oversaw its transformation from a small private company into a multi-national organization. He helped take the company public in 1976 and moved it to the New York Stock Exchange in 1997. While serving as Senior Vice President and CFO, he was responsible for all administrative and support organizations and was instrumental in its sale to Siemens Corporation in 2000. During Kyle's tenure, SMS grew from \$35 million in revenue and over 650 employees in the U.S. to \$1.6 billion in revenues and over 7,500 employees in 22 countries.

A CPA, Kyle began his career with Arthur Andersen & Company and is a member of the American Institute of Certified Public Accountants and the Pennsylvania Institute of Certified Public Accountants.
