Using the Taxability Manager, asset identifiers or codes from your financial system can be mapped to these categories, and jurisdiction-specific taxability can be automatically applied by the calculation system, thus eliminating the burden of per-transaction taxability determination. Tax professionals can also enter exemption certificates and direct-pay permit information associated with their customers. As a result, all exemption information is available quickly and efficiently, if needed during an audit. The Taxability Manager also provides your tax department with flexible set-up options – from full reliance on the system-supplied taxability rules to full customization according to your business practices, or even a combination of both options.

Customize Rules with Leasing Taxability Drivers

Lessors of vehicles and agricultural equipment need a way to base the taxability of property on the weight and horsepower of the equipment and the term of the lease – not just the tax jurisdiction and the customer's tax status. Vertex Leasing provides these additional parameters, which can be associated with a lease contract. These parameters also contain pre-populated rules for the most common dimensions for lease transactions, namely equipment weight and lease duration.

Successfully Manage Multiple Impositions
