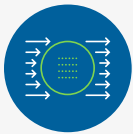

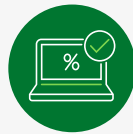

It integrates with Vertex Accelerator 3.1 reports for audit trail and FLUX Builder for easy corrections when exemption certificates are added in Vertex.

## FLUX Builder ●

FLUX Builder provides a proactive approach to certificate management with a comprehensive solution for checking, testing, and reporting on exemption certificates. It's compatible with Drop Shipment to help manage home state exemptions.

## FLUX Monitor ●●●●

FLUX Monitor simplifies tracking of changes made to SAP master data, tax configuration, and PLUS and/or Vertex Accelerator 3.1 tables, which could impact your tax calculations.

## SCOUT Conversion ●●

SCOUT offers a suite of conversion programs to handle SAP Tax Jurisdiction Code (TJC) updates. Whether you are implementing a new instance of Vertex tax solutions for SAP ERP or upgrading, SCOUT can help you validate and convert your addresses and your existing jurisdiction codes.

## SD Blocking ●
