#### **Reliable Data Management**

Vertex can accept your tax data in multiple formats from a wide range of tax calculation and/or host financial systems. This flexibility helps ensure that compliance is accurate and on time, regardless of the data structures that your financial systems provide. Each client's data is segregated and protected, and every client has 24/7 access to their data via an online portal.

#### Easy-to-Use Online Portal and Dashboard

When you outsource your sales tax returns to Vertex, you're always informed and in control, thanks to Vertex's online portal. It keeps you informed at every step and supports secure data and document transfers each month. An easy-to-use dashboard provides anytime/anywhere visibility into the status of returns, as well as complete visibility into your tax data, confirmations, notices, and all communication with tax jurisdictions.

#### **Secure Funds Management**

All payment confirmations are filed on the client portal. In addition, Vertex provides a monthly reconciliation of all funds requested and received.

## **Timely Notice and Credit Management**

Proper handling of notices is critical to maintaining your company's reputation with the taxing jurisdictions and the public. Your Vertex Returns Processor will manage all notices on your behalf in a timely and efficient manner, with complete documentation on the client portal to ensure transparency. Vertex has the unique ability to manage and track credits at the jurisdiction level and offset against current liabilities. Large carryforward balances that are not capable of being offset can be pulled out of our system so a refund can be requested.

#### **Detailed Reporting**

One of the most valuable resources a tax department has is information. From your Vertex dashboard, you can access a variety of reports each month to help you stay in control of the tax compliance process.

- The Tax Calendar Report provides a breakdown by filing entity and jurisdiction of exactly what returns are being filed for that given period. It also details net tax due and estimated funds to be transferred.
- The Reconciliation Report breaks down by filing entity and jurisdiction the data being used to file the returns, as well as rounding, credits, and carry-forward amounts.
- The 13-Month Trend Analysis Report gives a high-level look at the gross tax broken out by filing entity and jurisdiction.
