Additional Information

- There were no state sales tax changes in the first quarter of 2022.
- Puerto Rico currently has the highest state sales tax rate at 10.500%. Indiana, Mississippi, Rhode Island, and Tennessee have the second-highest state sales tax rates at 7.000%.
- Kodiak, Alaska, Wrangell, Alaska, and Winter Park, Colorado have the highest city sales tax rate at 7.000%. Hoonah, Alaska, Klawock, Alaska, and Selawik, Alaska have the second-highest rate of 6.500%.
- Sterlington, Ouachita Parish with the Sterlington Economic Development District No. 1 in Louisiana has the highest combined sales tax rate of 12.950%.
- Since 2012, there have been 2354 new sales and use taxes, an average 118 per year.
- Since 2012, there have been 3834 sales and use tax changes, an average of 192 per year.
- The combined number of new and changed sales and use tax rates since 2012 is 6188, an average of 310 per year.
