

Role-based dashboard provides comprehensive view of data across multiple source systems, enables users to monitor and track e-invoice status for AP and AR (including summary view(s), invoice details, actions to be taken), and easily download electronically archived e-invoices and related artifacts. Enables easy toggle between Vertex e-Invoicing and Vertex VAT Compliance applications for reconciliation between real-time and periodic reporting.



End to End VAT Compliance

Cloud-based end-to-end VAT platform supports data extraction, VAT ID registration, tax determination, compliant digital invoicing, and periodic and real-time reporting. Within a single user interface and shared dashboard, users can manage real-time and periodic reporting allowing for reconciliation across e-invoicing and VAT returns.
