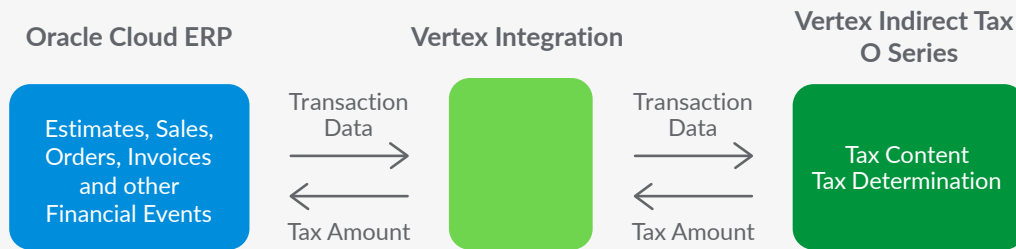

Vertex pulls the transaction details from Oracle to calculate indirect tax in Vertex O Series and send that tax amount back to Oracle.

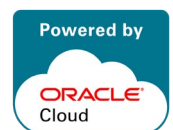
