Vertex Validator provides real-time and bulk validation of VAT ID numbers to mitigate commercial and compliance risk, and help ensure accurate VAT treatment at the point of transaction, avoid fraud, and comply with regulatory requirements of the reverse charge mechanism.

Automated Validation

Vertex Validator is an API-based solution that automates business tax ID validation. It enables the seller to collect and conduct validation at the most ideal point in the sales journey - customer onboarding or in real-time during the check-out process. The solution integrates with regional databases supporting 65+ countries to help ensure sellers fully comply with tax authority requirements across the globe. It provides various validation types, simple API for flexibility, and reporting to assist customer/vendor management and support audits.

Easy Integration

The API-based solution can be integrated into your workflows at the correct location to deliver validation that meets your use case, such as the sales workflow, customer onboarding, or to support e-invoicing, period reporting and filing. The cloudbased tool can be easily integrated into a seller's existing ERP, CRM, e-commerce, marketplace, or online platform.

The Reverse Charge Mechanism

A verified VAT ID is needed:

- for the reverse charge mechanism. The seller does not charge VAT, and the buyer self-assesses and pays the VAT in their home country. It typically applies to B2B cross-border services and to domestic transactions that are susceptible to VAT fraud, such as construction services or sales of mobile phones.
- 2. for zero-rated cross-border sales of goods within the EU. The seller charges 0% VAT, and the buyer is responsible for reporting and paying acquisition VAT in their destination country.

Flexible Validation Options

Supports direct single-transaction real-time validation, scheduled/ reoccurring (i.e., for subscription sellers), and batch validation.



API Integration

Local Requirements

Supports local requirements, exposing CAPTCHA to the buyer during checkout, and automates CAPTCHA resolution where necessary, e.g., India.



Dual Number Validation

Where applicable, can validate two VAT IDs in a single request to support countries where there is a requirement e.g., Canada federal and provincial tax IDs.



Validation Strategy Controls

UI-based controls to enable users to configure validation behavior per region, such as error management, timeouts, cache expiry or validation type.



Validation Event Data

Validated data can be exported in CSV or automatically ingested back to the source system via API to instruct the transaction and update customer records.
