



# Ryerson Improves O2C Operations with Vertex PLUS Tools for SAP ERP

# The Challenge

With a large population of tax-exempt customers and a complex tax landscape, Ryerson's tax team needed tools that could help them scale efficiently while maintaining compliance. On the AR side of their business, they faced several operational hurdles that impacted tax exemption management and tax credit accuracy:

- Difficulty proactively identifying and setting up exempt customers in their SAP ERP
- Manual, time-consuming processes for managing exemption certificates
- Communication gaps between sales and tax teams
- Labor-intensive tax credit adjustments and limited visibility into document flow

#### **The Solution**

Since 2017, Ryerson has trusted the Vertex O Series tax engine to provide real-time tax determination for their SAP ECC. To address its exemption and tax credit challenges, Ryerson again turned to Vertex for its purpose-built tools to streamline tax operations in SAP—specifically, FLUX Builder and flexRFC AR.

- With FLUX Builder, the tax team gained the ability to manage exemption certificates
  directly within SAP, eliminating the need to toggle between systems or manually
  create customer records in O Series. This integration allowed Ryerson to proactively
  identify new customers requiring exemption setup and initiate outreach before
  issues arose. The tool also enabled mass updates, such as expirations and changes,
  which significantly reduced administrative overhead and improved data accuracy.
- Meanwhile, flexRFC AR improved how Ryerson handled tax credits. By reading directly from original documents and following the document flow, the tool ensured that tax adjustments were accurate and aligned with the source data. This eliminated the need for manual research and reduced the risk of duplicating credits or introducing errors. The built-in reporting capabilities also proved invaluable for compliance, audits, and support for the tax team—all while reducing the need for coordination across departments.

Together, these tools empowered Ryerson's tax team to shift from reactive problem-solving to proactive strategy.
